## BACKGROUND

The London Borough of Barking and Dagenham Council is one of 32 local authorities in London. They deliver a wide range of essential services, from social care and council housing to licensing, waste disposal, and community safety. The Council also sets planning policy, manages environmental health, and supports vulnerable residents.

The Council engaged The DPO Centre to guide and support the rollout of new technology to assist elderly and vulnerable residents. This presented a complex information governance challenge that needed to be addressed so the initiative could move ahead safely, lawfully, and without delay.

## SOLUTION

A designated DPO worked closely with the Council teams to understand the proposed use of the new technology system and identify privacy risks early. A detailed Data Protection Impact Assessment (DPIA) was completed, enabling the Council to determine whether the proposed data processing was necessary and proportionate. This gave the Council the confidence to proceed, reducing the risk of challenge and delay.

Through collaborative discussions, a clear lawful basis was agreed for the processing. Public Task was identified as the most appropriate, reflecting the Council's statutory role in delivering social care and providing assurance that the initiative could be implemented while protecting the rights of elderly and vulnerable residents.
